INTRODUCTION

This Target Market Determination (**TMD**) is required under section 994B of the *Corporations Act 2001* (Cth) (**the Act**). This TMD describes the class of consumers that comprises the target market for the financial product and matters relevant to the product's distribution and review (specifically, distribution conditions, review triggers and periods, and reporting requirements). Target Market Summary

This product is intended for use as a satellite portfolio allocation for a consumer who is seeking capital growth and has a high risk and return profilefor that portion of their investment portfolio. It is likely to be consistent with the financial situation and needs of a consumer with a 5 year minimum investment timeframe and who is unlikely to need to withdraw their money on less than one week's notice period.
