SPIRE MULTIFAMILY GROWTH AND INCOME FUND FOUNDERS (AUD) HEDGED CLASS

INTRODUCTION

This Target Market Determination (TMD) is required under section 994B of the *Corporations Act 2001* (Cth) (**the Act**). This TMD describes the class of consumers that comprises the target market for the financial product and matters relevant to the product's distribution and review (specifically, distribution conditions, review triggers and periods, and reporting requirements). Distributors must take reasonable steps that will, or are reasonably likely to, result in distribution of the product being consistent with the most recent TMD (unless the distribution is excluded conduct).

This document is not a product disclosure statement (PDS) and is **not** a complete summary of the product features or terms of the product. This document does not take into account any person's individual objectives, financial situation or needs. Persons interested in acquiring this product should carefully read the PDS for the product before making a decision whether to buy this product.

Target Market Summary

This product is intended for use as a minor or satellite allocation for a consumer who is seeking capital growth and income distributions and has a high risk and return profile for that portion of their investment portfolio. It is likely to be consistent with the financial situation and needs of a consumer with a minimum 5 year investment timeframe and who is unlikely to need to withdraw their money on less than one quarter period's notice. This product is classified as a Fund of Hedge Fund under ASIC Regulatory Guide RG240 and may have complex features. This product is likely to be suitable for investors who have received personal advice.

INVESTMENT PRODUCTS AND DIVERSIFICATION

Solution/Standalone (up to 100%)	Not in target market	The Fund will invest primarily in the Blocker Fund, which will then invest in the Underlying Fund which predominantly invests in a portfolio of select US based Multifamily assets. The Fund will also invest in the Underlying ETF to provide liquidity within the Fund for the purpose of maintaining target investment level and satisfying redemption requests. The target investment allocation is as follows:
Major allocation (up to 75%)	Not in target market	- Underlying Fund 80%; - Underlying ETF 15%; and - Cash Amounts 5%.
Core component (up to 50%)	Not in target market	The Fund has no borrowings itself but has no control over the level of gearing at the Underlying Fund level, which has a maximum gearing limit of 50% loan to value ration (LTV). It is the intention of the Underlying Fund to maintain the overall level of gearing to no more than approximately 5% LTV.
Minor allocation (up to 25%)	In target market	The Fund (including the Underlying Fund and Underlying ETF) will not engage in short selling. The Fund will not use derivatives to gain exposure to certain assets or asset classes. For the Hedged Class, derivatives will be used for currency hedging purposes to mitigate the impact of changes in exchange rates between the AUD and the USD.

Within one week of request	Not in target market	Investors can submit an application to withdraw their investment by 5pm (Sydney time) on the 20th calendar day, or preceding Business Day in the event that the 20th is a New South Wales public holiday. Funds will generally be available by the 20th Business Day in the following month, where the Issuer has sufficient cash to pay the withdrawal proceeds. However the Issuer has discretion to make payment up to 1074 days following acceptance of a request. In certain circumstances the Fund may restrict redemption requests including by way of spreading redemption requests over a longer period of time (e.g. when redemption requests in any given quarter exceed 5% of Units on issue), or by making periodic redemption offers or suspending redemptions. When the Fund is not Liquid, investors may only request a redemption under the terms of any withdrawal offer made by the Responsible Entity. The Responsible Entity is not required to make a withdrawal offer where the Fund is not Liquid. The Fund is not suitable for investors who need regular access to their capital. Consumer's need to access capital

This consumer attribute addresses the likely period of time between the making of a request for redemption/withdrawal (or access to investment proceeds more generally) and the receipt of proceeds from this request under ordinary circumstances. Issuers should consider both the frequency for accepting the request and the length of time to accept, process and distribute the proceeds of such a request. To the extent that the liquidity of the underlying investments or possible liquidity constraints (e.g. ability to stagger or delay redemptions) could impact this, this is to be taken into consideration in aligning the product to the consumer's need to access capital. Where a product is held on investment platforms, distributors also need to factor in the length of time platforms take to process requests for redemption for underlying investments. Where access to investment proceeds from the product is likely to occur through a secondary market, the liquidity of the market for the product and likely realisable value on market should be considered, including in times of market stress.

Distributor Reporting

Significant dealings	<p data-bbox="495 689 2159 751">Section 994F(6) of the Act requires distributors to notify the issuer if they become aware of a significant dealing in the product that is not consistent with the TMD. Neither the Act nor ASIC defines when a dealing is 'significant' and distributors have discretion to apply its ordinary meaning.</p> <p data-bbox="495 751 2159 813">The issuer will rely on notifications of significant dealings to monitor and review the product, this TMD, and its distribution strategy, and to meet its own obligation to report significant dealings to ASIC.</p> <p data-bbox="495 813 2159 850">Dealings outside this TMD may be significant because:</p> <ul style="list-style-type: none"> • they represent a material proportion of the overall distribution conduct carried out by the distributor in relation to the product, or • they constitute an individual transaction which has resulted in, or will or is likely to result in, significant detriment to the consumer (or class of consumer). <p data-bbox="495 954 2159 991">In each case, the distributor should have regard to:</p> <ul style="list-style-type: none"> • the nature and risk profile of the product (which may be indicated by the product's risk rating or withdrawal timeframes), • the actual or potential harm to a consumer (which may be indicated by the value of the consumer's investment, their intended product use or their ability to bear loss), and • the nature and extent of the inconsistency of distribution with the TMD (which may be indicated by the number of red and/or amber ratings attributed to the consumer). <p data-bbox="495 1150 2159 1187">Objectively, a distributor may consider a dealing (or group of dealings) outside the TMD to be significant if:</p> <ul style="list-style-type: none"> • it constitutes more than half of the distributor's total retail product distribution conduct in relation to the product over the quarter, • the consumer's intended product use is <i>solution/standalone</i>, • the consumer's intended product use is core component or higher and the consumer's risk/return profile is <i>low</i>, or • the relevant product has a green rating for consumers seeking <i>extremely high</i> risk/return.
