MUZINICH EUROPEAN PARALLEL LENDING FUND

INTRODUCTION

This Target Market Determination (**TMD**) is required under section 994B of the *Corporations Act 2001* (Cth) (**the Act**). This TMD describes the class of consumers that comprises the target market for the financial product and matters relevant to the product's distribution and review (specifically, distribution conditions, review triggers and periods, and reporting requirements). Distributors must take reasonable steps that will, or are reasonably likely to, result in distribution of the product being consistent with the most recent TMD (unless the distribution is excluded conduct).

This document is not a product disclosure statement (**PDS**) and is **not** a complete summary of the product features or terms of the product. This document does not take into account any person's individual objectives, financial situation or needs. Persons interested in acquiring this product should carefully read the PDS for the product before making a decision whether to buy this product.

Target Market Summary

This product is intended for use as a satellite allocation for a consumer who is seeking income and has a high to very high risk and return profile for that portion of their investment portfolio. It is likely to be consistent with the financial situation and needs of a consumer with a minimum of five year investment timeframe and who is unlikely to need to withdraw their money on less than three months' notice and who is comfortable with the restrictions that may be imposed on withdrawal requests. This product is classified as a Hedge Fund under ASIC Regulatory Guide RG240 and may have complex features and is likely to be suitable for investors who have received professional financial advice.

INVESTMENT PRODUCTS AND DIVERSIFICATION

For example, a consumer may seek to construct a balanced or moderate diversified portfolio with a minor allocation to growth assets. The Master Fund primarily seeks to invest, directly or indirectly and on both a primary and secondary basis, in a diversified portfolio of debt instruments issued by European borrowers. The Master Fund will focus primarily on senior secured floating rate instruments, including syndicated loans and club loans. The Master Fund will primarily seek investment opportunities in which it co-invests with a bank or other investor, either through standard syndication or through a club deal. The Master Fund may also directly originate debt; however, loan origination is not the Master Fund's main investment strategy, and the notional value of the Master Fund's originated loans will represent less than 50% of the Master Fund's net asset value (NAV). The Master Fund will invest primarily in companies headquartered or with material business and operations in the European Investment Region and may pursue its investment objectives by investing in other undertakings for collective investment. The Fund will endeavor to hedge the currency exposure. However, there is no guarantee that the Fund will be hedged at all times, or that all currency risks will be mitigated. The Fund will not use leverage. The Master Fund, either directly or indirectly through one or more special purpose vehicles, may borrow for any purpose, including to increase investment capacity. The Master Fund's borrowing will not exceed 200% of the Master Fund's NAV.

Within one week of request	Not in target market	Withdrawal requests must be received by 2:00 pm (Sydney time) no less than 91 days before the last Business Day of each calendar month (Withdrawal Date). Units are withdrawn at a price per Unit equal to the NAV per Unit of the Fund as at the applicable Withdrawal Date. The Responsible Entity generally expects to receive payment from the Master Fund within 30 days of the Withdrawal Date. Once received, the Responsible Entity will finalise the redemption and pay proceeds to investors, which are generally expected to be paid within 35 days of the Withdrawal Date. An early redemption charge will be payable to the Master Fund where any Share Class is withdrawn before the 365th day following the date on which it was acquired by the Fund. The amount of the early redemption charge will be equal to 2% of the amount redeemed (after application of the performance fees), or such lower percentage as the Master Fund's board may agree either generally or on a case by case basis. The early redemption charge will be retained by the Master Fund and applied for the benefit of all investors in the Master Fund. The Master Fund applies redemption limits of 2% of NAV per calendar month and 5% of NAV per calendar quarter. Where redemption requests exceed these limits, they will be scaled back on a pro rata basis and may be deferred to subsequent redemption dates. Any gating or suspension at the Master Fund level may restrict the Fund's ability to meet withdrawal requests. A consumers desired product return profile will generally take into account the impact of fees, costs and taxes.

Medium	For the relevant part of the consumer's portfolio, the consumer: • has a moderate or medium risk appetite, • seeks low volatility and potential losses (e.g. has the ability to bear up to 4 negative returns over a 20 year period (SRM 3 to 5)), and • is comfortable with a moderate target return profile. The consumer typically prefers defensive assets (for example, fixed income).
High	For the relevant part of the consumer's portfolio, the consumer: • has a high risk appetite, • can accept high volatility and potential losses (e.g. has the ability to bear up to 6 negative returns over a 20 year period (SRM 5 or 6)), and • seeks high returns (typically over a medium or long timeframe). The consumer typically prefers growth assets (for example, shares and property).
Very high	For the relevant part of the consumer's portfolio, the consumer: • has a very high risk appetite, • can accept very high volatility and potential losses (e.g. has the ability to bear 6 to 7 negative returns over a 20 year period (SRM 6 or 7)), and • seeks very high returns (typically over a medium or long timeframe). Extremely high	For the relevant part of the consumer's portfolio, the consumer: • has an extremely high risk appetite, • can accept extremely high volatility and potential losses (eg. has the ability to bear more than 7 negative returns over a 20 year period), and • seeks to maximise returns (potentially in a short timeframe). The consumer seeks extremely high risk, speculative or complex products which may have features such as significant use of derivatives, leverage or short positions or may be in emerging or niche asset classes (for example, crypto-assets or collectibles).
Consumer's need to access capital	
This consumer attribute addresses the likely period of time between the making of a request for redemption/withdrawal (or access to investment proceeds more generally) and the receipt of proceeds from this request under ordinary circumstances. Issuers should consider both the frequency for accepting the request and the length of time to accept, process and distribute the proceeds of such a request. To the extent that the liquidity of the underlying investments or possible liquidity constraints (e.g. ability to stagger or delay redemptions) could impact this, this is to be taken into consideration in aligning the product to the consumer's need to access capital. Where a product is held on investment platforms, distributors also need to factor in the length of time platforms take to process requests for redemption for underlying investments. Where access to investment proceeds from the product is likely to occur through a secondary market, the liquidity of the market for the product and likely realisable value on market should be considered, including in times of market stress.	
Distributor Reporting	
Significant dealings	Section 994F(6) of the Act requires distributors to notify the issuer if they become aware of a significant dealing in the product that is not consistent with the TMD. Neither the Act nor ASIC defines when a dealing is 'significant' and distributors have discretion to apply its ordinary meaning. The issuer will rely on notifications of significant dealings to monitor and review the product, this TMD, and its distribution strategy, and to meet its own obligation to report significant dealings to ASIC. Dealings outside this TMD may be significant because: • they represent a material proportion of the overall distribution conduct carried out by the distributor in relation to the product, or • they constitute an individual transaction which has resulted in, or will or is likely to result in, significant detriment to the consumer (or class of consumer). In each case, the distributor should have regard to: • the nature and risk profile of the product (which may be indicated by the product's risk rating or withdrawal timeframes), • the actual or potential harm to a consumer (which may be indicated by the value of the consumer's investment, their intended product use or their ability to bear loss), and • the nature and extent of the inconsistency of distribution with the TMD (which may be indicated by the number of red and/or amber ratings attributed to the consumer). Objectively, a distributor may consider a dealing (or group of dealings) outside the TMD to be significant if: • it constitutes more than half of the distributor's total retail product distribution conduct in relation to the product over the quarter, • the consumer's intended product use is <i>solution/standalone</i>, • the consumer's intended product use is core component or higher and the consumer's risk/return profile is <i>low</i>, or • the relevant product has a green rating for consumers seeking <i>extremely high</i> risk/return.
